ABSTRACT

ANIZA NURAINI. *Anas Urbaningrum's Representation in the Jakarta Post and Jakarta Globe Online Newspaper on Hambalang Case.* 2014. English Department, Faculty of Languages and Arts, Universitas Negeri Jakarta.

This study aimed to see Anas Urbaningrum's representation in six of news articles taken from the two online newspapers, the Jakarta Post and Jakarta Globe. This study used Systemic Functional Linguistic (SFL) theory by M.A.K Halliday which provides the types of process in a clause. This study is also analyzed the thematic structure of the clauses to support the analysis of types of process. The research method of this study is descriptive analytical interpretative method. There are totally amount 207 clauses from the six news articles in both newspapers, 122 clauses from the Jakarta Post and 85 clauses from Jakarta Globe. This study shows that the dominant process in both newspapers is verbal process. In the Jakarta Post, the verbal process are 47 clauses (37%), while in the Jakarta Globe, the verbal process are 36 clauses (42%). From those results, it can be said that the Jakarta Post and Jakarta are in the same way in representing Anas Urbaningrum. Anas is represented as the one wants to clarify and defend himself from the accusations he had in Hambalang case. The journalist used the verbal process to cited the Anas's statements for showing the Hambalang case based on the Anas's view. The analysis of thematic structure in both newspapers show that Anas as the dominant topical theme which indicates that Anas as the main topic of the articles. (An)

ABSTRAK

ANIZA NURAINI. *Representasi Anas Urbaningrum dalam Surat Kabar Online Jakarta Post dan Jakarta Globe pada Kasus Hambalang.* 2014. **Bahasa dan Sastra Inggris, Fakultas Bahasa dan Seni, Universitas Negeri Jakarta.**

Penelitian ini bertujuan untuk melihat representasi Anas Urbaningrum dalam 6 artikel berita dari dua surat kabar online, Jakarta Post dan Jakarta Globe. Penelitian ini menggunakan teori Systemic Functional Linguistic (SFL) dari M.A.K Halliday yang didalamnya mencakup jenis-jenis proses didalam sebuah klausa. Penelitian ini juga mencakup analisa struktur tematik dalam klausa untuk mendukung analisa jenis proses. Metode penelitian yang digunakan adalah metode analisis deskriptif interpretatif. Dari enam artikel berita terdapat total 207 klausa, 112 klausa dari Jakarta Post dan 85 klausa dari Jakarta Globe. Penelitian ini memperlihatkan adanya proses dominan yaitu proses lisan (verbal process). Dari Jakarta Post terdapat proses lisan sebanyak 47 klausa (37%), sedangkan didalam Jakarta Globe terdapat proses lisan sebanyak 36 klausa (42%). Dari hasil tersebut dapat dikatakan bahwa Jakarta Post dan Jakarta Globe merepresentasikan Anas dengan cara yang sama. Anas direpresentasikan sebagai seseorang yang berusaha mengklarifikasi dan melindungi dirinya dari tuduhan yang ditujukan kepadanya dalam kasus Hambalang. Jurnalis menggunakan proses lisan (verbal process) untuk mengutip pernyataan dari Anas guna menggambarkan kasus Hambalang berdasarkan pandangan Anas. Analisa struktur tematik menunjukkan bahwa Anas sebagai dominan tema topikal yang mengindikasikan Anas sebagai topik utama dalam keseluruhan artikel. (An)


